At this busy time of year, we recommend sending files in a few days in advance to allow for unforeseen delays.

Client Runs - Vancouver/New Westminster

December 24 - Our offices will be closed at 12:00 p.m.

❖ There will be no client runs operating after 11:00 a.m.

The last inter-office run leaving our Vancouver office for New Westminster will be at 11:00 a.m. The last inter-office run leaving our New Westminster office for Vancouver will be at 9:30 a.m.

December 31 – Our offices will be closed at 3:00 p.m.

There will be no client runs operating after 1:00 p.m.

The last inter-office run leaving our Vancouver office for New Westminster will be at 1:15 p.m. The last inter-office run leaving our New Westminster office for Vancouver will be at 2:15 p.m.



File/Register - Vancouver & New Westminster

On **December 24th** and **31st**, our run system and offices will be closing early. If you have documents that must be filed on those days, please send them in as early as possible or <u>the day before</u>. For urgent documents, please let us know in advance. (Van - 604-659-8700 / NW - 604-659-8600)

Provincial & Out-of-Area Courts - There will be no runs to most outlying registries on December 24th.



- Abbotsford, Chilliwack, Port Coquitlam, Surrey and Richmond: We will not be attending on December 24.
 - All other dates, work to be filed must be in our New Westminster office by 10:30 a.m.
- ❖ North Vancouver We will attend on December 24.
 - Work to be filed must be in our Vancouver office by 9:30 a.m.
- **❖ OUT-OF-AREA COURT:**

Work for Out-of-Area must be in our Vancouver office, 3 or more days, in advance:

- > for filing on <u>December 24</u> by 1:00 p.m. on December 19
- for filing on <u>December 31</u> by 11:00 a.m. on December 24
- for filing on <u>January 2</u> by 1:00 p.m. on December 30

Victoria to/from Vancouver

Our <u>overnight</u> courier service will leave from both our Vancouver and Victoria offices at 12:00 p.m. on December 24 and December 31. Work to be filed in **VICTORIA or VANCOUVER/NW** must be in the 'sending' office by the following times:

- For filing on December 29
 - Work must be in the sending office (Vancouver or Victoria) by 11:00 a.m. on December 24
- For filing on January 2
 - Work must be in the <u>sending</u> office (Vancouver or Victoria) by 11:00 a.m. on <u>December 31</u>

Weather Warning

- **OVERNIGHT SERVICE TO VICTORIA or OUT-OF-TOWN REGISTRIES:**
 - Flight schedules can change, or be cancelled, without warning during the winter season.
 - > Ground couriers can also be cancelled or delayed for extended periods, without warning, due to volume or weather.

We advise you not to rely on overnight couriers for submission/registration of work sent on a 'Rush' or 'Urgent' basis. Instead, we advise you to send your documents to us at least three days (or more) before your deadline for filing.
